 - b. Bank Statement to support income claimed, or a letter from the Banker confirming the applicant's ability to service a minimum debt of TT\$5,000 per month (per horse), or financial information on the business to support the specified minimum debt liability (as determined by the Authority).
 - 7. Police Certificate of Character.
