

# MEDIA RELEASE

The Board of the Authority hereby advises of decisions taken at its meeting held on **Tuesday July 09 2013**.

**1. ENQUIRY INTO THE FINDING OF PROHIBITED SUBSTANCES 'PHENYLBUTAZONE OXYPHENBUTAZONE' AND FLUNIXIN IN THE SAMPLE OF EQUINE URINE AND BLOOD No. 526145 TAKEN FROM 'ENIGMATIC', WINNER OF RACE 6 / DAY 04 OF THE 2013 RACING SEASON HELD ON SATURDAY JANUARY 26, 2013**

Having given due consideration to the evidence of Mr. Glen Mohammed Trainer, Mr. Edwin Persad Groom and that of Mr. Nicholas Beepath and Mr. Herman Suraj Paddock Officials of the Club, the Board has found Mr. Mohammed to be in breach of **Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing**.

Therefore, pursuant to **Rule Nos: 62 (8) 100 (B) (4) of the Rules of Racing**, the Board has decided to suspend him for a period of **three (3) months** with effect from **July 15, 2013**, fine him the sum of **five hundred dollars (\$500.00)** and further in accordance with **Rule Nos. 7 (4) (q) and 63 (1)** declare him a disqualified person for the period stated above.

During the period of his disqualification, he will be debarred from entering any racecourse premises here or elsewhere.

In accordance with **Rule 100 (B)(4) of the Rules of Racing 'ENIGMATIC'**, has been disqualified from **1<sup>st</sup> place**. The revised results for the race in question are as follows:

**2. ENQUIRY INTO THE FINDING OF PROHIBITED SUBSTANCE "PROCAINE", IN THE SAMPLE OF EQUINE URINE No. 526141 TAKEN FROM 'SCHYLER'S GOLD (USA)', WINNER OF RACE 4 / DAY 06 OF THE 2013 RACING SEASON HELD ON SATURDAY FEBRUARY 16, 2013**

Having given due consideration to the evidence of Dr. Anthony Griffith and that of Mr. Clint Richards Groom, the Board has found Dr. Griffith to be in breach of **Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing**.

Therefore, pursuant to **Rule Nos: 62 (8) 100 (B) (3) of the Rules of Racing**, the Board has decided to suspend him for a period of **Three (3) months** with effect from **July 15, 2013**, fine him the sum of

Two Hundred and Fifty dollars (\$250.00) and further in accordance with Rule Nos. 7 (4) (q) and 63 (1) declare him a disqualified person for the period stated above.

During the period of his disqualification, he will be debarred from entering any racecourse premises here or elsewhere. In this regard your attention is drawn to Rule Nos. 63 and (42) (20) of the Rules of Racing.

The Board has exonerated Mr. Clint Richards the Groom from any blame in this matter.

In accordance with Rule 100 (B)(3) of the Rules of Racing the horse 'SCHYLERS GOLD (USA)', has been disqualified from 1<sup>st</sup> position the revised results of the race in question is as follows:

**3. ENQUIRY INTO THE FINDING OF PROHIBITED SUBSTANCE AMBROXOL IN THE SAMPLE OF URINE 526197 TAKEN FROM 'WHO IS THE PROBLEM', WINNER OF RACE 4 / DAY 8 OF THE 2013 RACING SEASON – SATURDAY 2 MARCH, 2013**

Having given due consideration to the evidence of Mr. Harry Singh Trainer, and that of Mr. John Lynch Groom, the Board has found Trainer Harry Singh and Groom John Lynch to be in breach of Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing.

Therefore, pursuant to Rule Nos: 62 (8) 100 (B) (4) of the Rules of Racing, the Board has decided to suspend them for a period of one month with effect from July 15, 2013, fine them the sum of Two Hundred and Fifty Dollars each (\$250.00) and further in accordance with Rule Nos. 7 (4) (q) and 63 (1) declare them disqualified persons for the period stated above.

During the period of their disqualifications, they will be debarred from entering any racecourse premises here or elsewhere.

In accordance with Rule 100 (B)(4) of the Rules of Racing the horse 'WHO IS THE PROBLEM', has been disqualified from 1<sup>st</sup> place. The revised results of the race in question are as follows:

1. *ZIPITUP*
2. *PRADOS WELLS*
3. *DIAMOND QUEEN (BAR)*
4. *RED HOWLER*
5. *WILDWILDWES*
6. *RICHES ABOUND (USA)*

**4. HEARING OF THE APPEAL LODGED BY APPRENTICE DILLON KHELAWAN RIDER OF MALIBU HEIGHTS UNPLACED FINISHER IN RACE 7/ DAY 06 – SATURDAY FEBRUARY 16, 2013 AGAINST THE DECISION OF THE STEWARDS TO SUSPEND HIM FOR ONE (1) DAY**

After considering the grounds of his appeal, hearing his evidence that of Mr. Rohit Dube, Trainer of Malibu Heights, Mr. Richard Freeman, Steward of the Arima Race Club and Dr. Shivana Beharry, Official Veterinarian and viewing the replay of the race, the Board found as follows.

The Board found that there was no merit whatsoever in the grounds of his appeal and as such it has been disallowed.

Further to this and in accordance with **Rule 7 (4) (L)** the Board agreed that due to the nature of the offence it extended his suspension by a further two (2) racedays.

As such he has been suspended from race riding for three (3) racedays after the raceday of Saturday 13, July 2013.
