MEDIA RELEASE

The Trinidad and Tobago Racing Authority hereby advises of decisions taken at its meeting held on Tuesday August 29th, 2017

1. Inquiry into the finding of 'STANOZOLOL' (Class IV), in excess of the established threshold pursuant to the Trinidad & Tobago Rules of Racing, in the sample of equine blood No. 0094196 taken from "**GLORIFY**", winner of Race 6/Day 22 on Saturday July 22nd, 2017

Having given due consideration to the evidence submitted by Mr. George Villiers (Trainer) and Mr. Shawmus Rodrigo (Groom), the Board had found Mr. Villiers to be in breach of Rule Nos. 62(8), 63(1) and 102(1) (d) of the Rules of Racing.

Therefore pursuant to Rule Nos. 62(8) and 100(B)(4) of the Rules of Racing, the Board decided to fine Mr. Villiers a sum of Five Hundred Dollars (\$500.00), impose a loss of purse and suspend his Trainer's licence for a period of nine (9) calendar months, from Monday 4th September 2017 to June 3rd, 2018.

In accordance with Rule 100 (B)(4) and 31(3) of the Rules of Racing, 'GLORIFY' has been disqualified from 1st place and the revised results of the race in question are as follows:

2. Inquiry into the finding of 'DEXAMETHASONE' (Class IV), in excess of the established threshold pursuant to the Trinidad & Tobago Rules of Racing, in the sample of equine blood No. 0094189 taken from "WINNING REPORT", winner of Race 5/Day 19 of the 2017 racing season which was held on Saturday June 24th, 2017

Having given due consideration to the evidence submitted by Dr. Anthony Griffith (Trainer) and Mr. Eustace Joseph Roberts (Groom), the Board had found Dr. Griffith to be in breach of Rule Nos. 62(8), 63(1) and 102(1) (d) of the Rules of Racing.

Therefore pursuant to Rule Nos. 62(8) and 100(B)(4) of the Rules of Racing, the Board decided to fine Dr. Griffith a sum of Five Hundred Dollars (\$500.00), impose a loss of purse and suspend his Trainer's licence for a period of one (1) calendar month, from September 1st to September 30th, 2017.

In accordance with Rule Nos. 100 (B)(4) and 31(3) of the Rules of Racing, 'WINNING REPORT', has been disqualified from 1st place and the revised results of the race in question are as follows:
