**RENEWAL OF OWNERS LICENCES**

THE TRINIDAD & TOBAGO RACING AUTHORITY WISHES TO REMIND ALL **OWNERS/COMPANIES/SYNDICATES** IN POSSESSION OF VALID LICENCES OF WHICH THE EXPIRY DATE IS NOVEMBER 30TH, 2021 (SEE RULE #34(26) AMENDED 1ST AUGUST 2020).

**RULE 34 (26): RENEWAL OF LICENCES APPLIED FOR, AFTER NOVEMBER 30<sup>TH</sup> SHALL ONLY BE GRANTED AT THE DISCRETION OF THE AUTHORITY AND WILL BE SUBJECT TO A LATE RENEWAL PENALTY.**

APPLICATION FORMS ARE AVAILABLE AT THE REGISTRY OFFICE OF THE TRINIDAD & TOBAGO RACING AUTHORITY, SANTA ROSA PARK, ARIMA, TEMPORARILY LOCATED AT THE ROA LOUNGE, PADDOCK ENTRANCE AND ON THE AUTHORITY'S WEBSITE [www.ttra.net](http://www.ttra.net). FORMS MUST BE FULLY COMPLETED BY THE OWNER OR HIS/HER DULY APPOINTED AUTHORISED AGENT ON HIS/HER BEHALF **ALONG WITH ONE (1) PASSPORT SIZED PHOTOGRAPH TAKEN AGAINST A WHITE BACKGROUND**. FORMS OBTAINED ON THE WEBSITE MUST BE COMPLETED AND PRINTED.

IN THIS REGARD FOR LICENCES WHICH EXPIRE ON **NOVEMBER 30<sup>TH</sup> 2021**, RENEWALS WILL BEGIN FROM **NOVEMBER 2<sup>ND</sup>, 2021** FOR THE 2022 RACING SEASON. FAILURE TO RENEW AFTER THE SAID DATE WILL RESULT IN A FEE FOR LATE RENEWAL OF \$100.00. **SEE RULE 34 (26) ABOVE.**

OWNERS ARE ASKED TO PLEASE NOTE THAT RENEWALS CAN BE EFFECTED FOR ANY PERIOD UP TO **THREE (3) YEARS** BY PAYMENT OF THE REQUIRED FEE, MULTIPLIED BY THE NUMBER OF YEARS.

PLEASE NOTE AND BE GUIDED ACCORDINGLY.
