

**TRINIDAD AND TOBAGO RACING AUTHORITY
STALLION/MARE RETURNS 2022**

THE ATTENTION OF ALL BREEDERS (STALLION/MARE OWNERS) IS DRAWN TO THE **DEADLINE DATE - SEPTEMBER 30, 2022** FOR LODGING OF APPROPRIATE RETURNS TO THE TRINIDAD AND TOBAGO RACING AUTHORITY, WITH RESPECT TO THE FOLLOWING: -

(i) STALLION RETURNS: LIST OF ALL MARES BRED TO A STALLION(S) DURING THE 2022 BREEDING SEASON, HIGHLIGHTING THE DATE OF FIRST SERVICE AND LAST SERVICE BY THE STALLION.

(ii) MARE RETURNS: REPORT OF THE STATUS IN 2022, OF ALL MARES COVERED DURING THE 2021 STUD SEASON, INSOFAR AS:

- (A) WHETHER MARE HAD A LIVE FOAL, IF SO, DETAILS OF DATE OF BIRTH, COLOUR AND SEX TO BE STATED.
- (B) WHETHER MARE HAD A FOAL WHICH HAS DIED SINCE BIRTH.
- (C) WHETHER MARE SLIPPED/ABORTED.
- (D) WHETHER MARE WAS BARREN.
- (E) WHETHER MARE HAS DIED SINCE 2021 COVERING, OR BEEN EXPORTED.

FOR PURPOSES OF THE STUD BOOK, BREEDERS ARE KINDLY ASKED TO REPORT ON ALL MARES ACTIVE IN 2022.

STALLION RETURNS/REPORT OF MARES BRED FORMS FOR THE YEAR 2022 ARE AVAILABLE AT THE REGISTRY OFFICE OF THE TRINIDAD AND TOBAGO RACING AUTHORITY, SANTA ROSA PARK, ARIMA, AT NO COST.

INDIVIDUAL MARE RETURN FORMS HAVE ALREADY BEEN PREPARED FOR EACH MARE FOR WHICH A STALLION RETURN WAS SUBMITTED IN 2021. MARE OWNERS ARE ASKED TO CHECK THE INFORMATION APPEARING ON THESE FORMS, COMPLETE IN DETAIL AND RETURN SAME TO THE AUTHORITY *ON OR BEFORE* THE DEADLINE DATE OF **SEPTEMBER 30TH, 2022.**

OWNERS OF STALLIONS AND MARES ARE ASKED TO NOTE THAT IT IS NOW COMPULSORY TO SUBMIT TO THE AUTHORITY THE UPDATED VACCINATION RECORDS OF STALLIONS AND MARES AT STUD BY 30TH SEPTEMBER 2022. FAILURE TO DO SO MAY RESULT IN THE NON-ISSUE OF SERVICE CERTIFICATES FOR ANY STALLION OR MARE. OWNERS/BREEDERS ARE URGED TO NOTE THAT THE EARLY SUBMISSION OF THEIR COMPLETED MARE RETURNS WILL FACILITATE THE EARLY PREPARATION OF THE DNA MARKER KITS FOR DISTRIBUTION TO OWNERS OF FOALS TO BE REGISTERED.

PLEASE BE ADVISED THAT RETURNS RECEIVED AFTER THE DEADLINE DATE WILL BE SUBJECTED TO PENALTIES.

(WHERE THE DEADLINE FOR REGISTRATION FOR STUD DUTY FALLS ON A WEEKEND OR HOLIDAY, THE DEADLINE DATE WILL BE THE NEXT WORKING DAY).
