RE: REQUIREMENTS FOR REGISTRATION AS AN OWNER

THE BOARD OF THE AUTHORITY HAS OBSERVED THAT DURING THE LAST EIGHTEEN (18) MONTHS THERE HAS BEEN A STEADY INCREASE IN THE NUMBER OF REPORTS RECEIVED AS A RESULT OF RACEHORSES IN THE PADDOCK BEING NEGLECTED. THE MAJORITY OF INSTANCES REVEALED THAT OWNERS WERE NOT PROVIDING THE NECESSARY FINANCIAL RESOURCES TO SUPPORT THE WELFARE OF THE ANIMALS

AS A RESULT OF THIS, THE BOARD HAS DECLARED THAT IT RESERVES THE RIGHT TO DETERMINE THE FINANCIAL RESPONSIBILITY AND CHARACTER OF ALL NEW APPLICANTS AS OWNERS.

AS SUCH, THE BOARD HAS DIRECTED THAT THE FOLLOWING WILL BE THE GUIDELINES FOR DETERMINING FINANCIAL RESPONSIBILITY AND CHARACTER OF APPLICANTS.

THE PROVISION OF ANY OF THE FOLLOWING THAT THE BOARD MAY REQUIRE TO COMPLETE ITS APPROVAL OF APPLICANTS.

1. * COPIES OF TWO (2) FORMS OF IDENTIFICATION - DP/ ID/ PASSPORT
2. JOB LETTER FROM EMPLOYER
3. * COPY OF UTILITY BILL (MOST RECENT)
4. IF APPLICANT IS THE DIRECTOR IN A COMPANY, A LETTER SIGNED BY THE COMPANY SECRETARY OR ANOTHER DIRECTOR CONFIRMING THIS AND INCLUDING THE PERSON'S SALARY / INCOME
5. IF THE APPLICANT IS SELF EMPLOYED HE IS REQUIRED TO SUBMIT THE ITEMS AT (1) AND (3) ABOVE TOGETHER WITH THE FOLLOWING :
 - (a) EVIDENCE OF TYPE OF BUSINESS - (REGISTRATION CERTIFICATE)
 - (b) BANK STATEMENT TO SUPPORT INCOME CLAIMED OR LETTER FROM BANKERS CONFIRMING ABILITY TO SERVICE DEBT OF \$4,000.00 /MTH OR FINANCIAL INFORMATION ON THE BUSINESS TO SUPPORT A \$4,000.00 DEBT LIABILITY

* THESE ITEMS ARE MANDATORY FOR ALL APPLICANTS.
