Each owner in question must also furnish the Secretary of the Trinidad and Tobago Racing Authority with a letter signed by him indicating that in the event of the applicant obtaining a licence as a trainer, he will employ the applicant as trainer for the horse mentioned for at least (10) race-days and that failure to honour the undertaking given will result in the non-acceptance of the entry of the horse in a race..

**GUIDELINES FOR THE GRANT OF LICENCE AS A TRAINER**

1. At least five horses to train, with supporting letters from owners.
2. Ability to read and write.
3. Thorough and working knowledge of the Rules of Racing.
4. Knowledge of equipment and its uses.
5. Knowledge of physical structure of a horse.
6. Knowledge of common ailments and their treatment.
7. General training.
8. Association with horses for a minimum of three years..
9. Certificate of good character from Police.
10. Stable management.

**DECLARATION:**

I declare that all answers given in my application for a Trainer's Licence are correct, and I hereby request that I be licenced as a Trainer by the Trinidad and Tobago Racing Authority. (T.T.R.A.)

I agree, upon being licenced, to be bound in all respects by the Rules of Racing in force from time to time and to accept the jurisdiction of the T.R.R.A. in all matters concerning horses trained by me. I further agree that if at any time I cease to be a trainer of a horse in racing I will surrender my Badge to the Trinidad and Tobago Racing Authority, (T.T.R.A.)
