

# PRESS RELEASE

The Board of the Authority hereby advises of decisions taken at its meeting held on Tuesday August 12, 2014.

1. ENQUIRY INTO THE FINDING OF SUBSTANCE FUROSEMIDE IN THE SAMPLE OF EQUINE BLOOD NO. 0041043 TAKEN FROM 'SPECTACULAR RETURN' WINNER OF RACE 2/DAY 12 OF THE 2014 RACING SEASON HELD ON SATURDAY MARCH 29TH, 2014 AND WHICH WAS NOT ADMINISTERED LASIX IN ACCORDANCE WITH THE RULES.

Having given due consideration to the evidence of Trainer Rohit Dube, and that of Mr. Denny Rampersad Groom, Dr. Clive Rahamut Ali Jnr. and Dr. Rossi Bridgelal attending Veterinarians the Board found Mr. Dube to be in breach of Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing.

Therefore, pursuant to Rule Nos: 62 (8) 100 (B) (4) of the Rules of Racing, the Board fined him the sum of Five Hundred dollars (\$500.00).

In addition and in accordance with Rule 100 (b) (4) of the Rules of Racing 'SPECTACULAR RETURN' has been disqualified from first place and the revised results of the race in question are as follows:

1. HOTEL CALIFORNIA
2. UNGUARDED MOMENT
3. WAKA WAKA
4. ADVENTAGE THEM
5. GOLDEN MISTRESS

Further to this the Board in hearing the evidence of Mr. Dube and by his own submission confirmed that Mr. Denny Rampersad was not the groom of this horse.

As such, the Board found that Mr. Dube made a false declaration on his entry which could have seriously jeopardized the career of Mr. Rampersad. For this the Board agreed that he be fined the amount of Five Hundred Dollars (\$500.00).

2. ENQUIRY INTO THE FINDING OF SUBSTANCES CAFFEINE AND THEOPHYLLINE IN THE SAMPLE OF EQUINE URINE AND BLOOD NO. 533242 TAKEN FROM 'LUVDATCAT' WINNER OF RACE 1/DAY 6 OF THE 2014 RACING SEASON HELD ON SATURDAY FEBRUARY 8TH, 2014.

Having given due consideration to the evidence of trainer Dube, and that of Mr. Robert Lochan Groom, and Dr. Rossi Bridgelal attending Veterinarian the Board found Mr. Dube to be in breach of Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing.

Therefore, pursuant to Rule Nos: 62 (8) 100 (B) (2) of the Rules of Racing, the Board fined Mr. Dube the sum of Five Hundred dollars (\$500.00) and suspended his Trainer's licence for a period of six (6) months with effect from Monday August 18, 2014.

Further, the Board in accordance with Rule 7 (4) (q) of the Rules of Racing declared him a disqualified person for the period stated above.

During the period of his suspension, he will be debarred from entering any racecourse premises here or elsewhere. In this regard, your attention is drawn to Rule Nos. 63 and 42(20) of the Rules of Racing.

In addition and in accordance with Rule 100 (B) (3) of the Rules of Racing LUVDATCAT has been disqualified from first place and the revised results of the race in question are as follows:

1. RESURGENCE
2. RED RIVER
3. THE CHEERLEADER
4. UNBRIDLED PLEASURE
5. FAITH N' FORTUNE

3 ENQUIRY INTO THE FINDING OF PROHIBITED SUBSTANCE STANZOLOL IN THE SAMPE OF EQUINE BLOOD NO. 0041129 TAKEN FROM 'CRAMERS RULE (JAM)' WINNER OF RACE 2/DAY 16 OF THE 2014 RACING SEASON HELD ON SATURDAY MAY 3<sup>RD</sup> 2014

Having given due consideration to the evidence of Mr. Chadee, the Board found him to be in breach of Rule Nos. 62 (8), 63 (1) and 102 (1) (d) of the Rules of Racing.

Therefore, pursuant to Rule Nos: 62 (8) 100 (B) (3) of the Rules of Racing, the Board, fined Mr. Chadee the sum of Five Hundred dollars (\$500.00) and suspend his Trainer's licence for a period of three (3) months with effect from Monday August 18, 2014.

Further and in accordance with Rule 7 (4) (q) of the Rules of Racing the Board declared Mr. Chadee a disqualified person for the period of his suspension.

During the period of his suspension, he will be debarred from entering any racecourse premises here or elsewhere. In this regard, your attention is drawn to Rule Nos. 63 and 42(20) of the Rules of Racing.

In addition and in accordance with Rule 100 (B) (3) of the Rules of Racing 'CRAMERS RULE (JAM)' has been disqualified from first place and the revised results of the race in question are as follows:

1. WING COMMANDER
2. RED HOWLER
3. BIG PROFIT
4. CARO'S LEGACY (USA)
5. ALWAYS A PRINCESS
