PRESS RELEASE

The Authority hereby informs of a decision taken at its meeting held on Thursday February 7, 2019 on the undermentioned matter.

INQUIRY INTO THE FINDINGS OF THE SUBSTANCE "STANOZOLOL", TAKEN FROM THE SAMPLE OF EQUINE BLOOD NO. 73911 TAKEN FROM 'MAN ON FIRE', WINNER OF RACE 4/DAY 3 OF THE 2019 RACING SEASON HELD ON SATURDAY JANUARY 19th, 2019

Having given due consideration to the evidence provided by Owner/Trainer Jimmy Rampersad and that of Mr. Leo Terrance Agnoo, the Board exonerated Mr. Leo Terrance Agnoo and found Trainer Jimmy Rampersad to be in breach of Rule Nos. 62(8), 63(1) and 102(1) (d) of the Rules of Racing.

Therefore, pursuant to Rule Nos. 62(8) and 100(8)(4) of the Rules of Racing, the Board has decided to fine Mr. Jimmy Rampersad the sum of Five Hundred Dollars (\$500.00), disqualify the horse from 1st place (loss of purse) and suspend Mr. Rampersad's Trainer's licence for a period of one (1) calendar month, from Tuesday 12th February, 2019 to Wednesday 13th March, 2019.

In accordance with Rule 100(B)(4) and 31(3) of the Rules of Racing, "MAN ON FIRE", has been disqualified from 1st place. "MAN ON FIRE" currently is serving a thirty-day suspension which ends on March 2nd 2019.
