Re: URGENT MATTERS AFFECTING 2 YR OLDS OF 2020 - (FOALS OF 2018)

This serves to advise that the Board of the Trinidad and Tobago Racing Authority has approved an extension of the deadline date by which **Urgent Matters Affecting 2 Year Olds of 2020** (Foals of 2018) must be addressed.

The **extended deadline date** by which the following **Matters Affecting 2 Year Olds of 2020** must be addressed, is **JULY 31ST, 2020**:

- **VACCINATION RECORDS WITH BATCH STICKER (UPDATED - FLU VAC, RHINO, TETANUS) - TO BE LODGED WITH THE AUTHORITY.**
- **TWO (2) SETS OF FOUR (4) COLOURED PHOTOGRAPHS (SIZE 3 1/2" X 5") OF EACH HORSE. HORSES SHOULD HAVE BEEN PHOTOGRAPHED BETWEEN FEBRUARY 1ST AND MARCH 15TH 2020 IN ACCORDANCE WITH THE RULES FOR REGISTRATION OF HORSES.**
- **SUBMISSION OF APPLICATIONS FOR THE NAMING OF HORSES. (ORIGINAL DEADLINE DATE MARCH 31ST 2020). (EXTENDED DEADLINE DATE - JULY 31ST, 2020)**
- **REGISTRATION OF CHANGE OF OWNERSHIP (PARTICULARLY IF HORSE WAS SOLD AT THE SFA YEARLING SALE) AND MICROCHIPPING OF HORSES PRIOR TO HORSE BEING ELIGIBLE TO TAKE ENTRY TO RACE.**
- **APPOINTMENT OF TRAINER, AUTHORISED AGENT AND POWER OF ENTRY, PRIOR TO HORSE BEING ELIGIBLE TO TAKE ENTRY TO RACE.**
