NAMING OF 2 YEAR OLDS

MATTERS AFFECTING 2 Y.O. OF 2024

OWNERS AND TRAINERS ARE REMINDED OF THE FOLLOWING MATTERS TO BE ADDRESSED WITH RESPECT TO THE 2 Y.O. OF 2024 (FOALS OF 2022).

- VACCINATION RECORDS WITH BATCH STICKER (UPDATED - FLU VAC, RHINO, TETANUS) - TO BE LODGED WITH THE AUTHORITY.
- Two (2) SETS OF FOUR (4) COLOUR PHOTOGRAPHS (SIZE 3 1/2" x 5") OF EACH HORSE. HORSES SHOULD BE PHOTOGRAPHED BETWEEN **FEBRUARY 1ST AND MARCH 15TH 2024** IN ACCORDANCE WITH THE RULES FOR REGISTRATION OF HORSES.

GUIDELINES FOR TAKING PHOTOS:

- IT IS IMPORTANT TO PLACE THE HORSE ON A SMOOTH, FLAT, DRY SURFACE. ANY OTHER SURFACE SUCH AS SAND OR GRASS WILL PREVENT THE IDENTIFIER FROM CHECKING LOWER LEG MARKINGS.
- PHOTOGRAPHS SHOULD BE TAKEN OUTDOORS WITH THE SUN AT YOUR BACK AND SHADOWS FALLING AWAY FROM THE HORSE. BACKGROUND IS IMPORTANT – DO NOT STAND A DARK HORSE AGAINST A BLACK BARN.
- MAKE CERTAIN THE HORSE IS CLEAN, DRY AND PROPERLY FRAMED IN THE PHOTOGRAPH. ENSURE ALL LEGS AND MARKINGS ARE VISIBLE FROM ALL ANGLES. STAGGER THE LEGS TO SHOW A CLEAR VIEW OF THE NIGHT EYES (CHESTNUTS). THE HORSE MUST BE CLEAN OF ANY DIRT, DUST OR MUD. FOR IDENTIFICATION PURPOSES AN IDENTIFICATION SIGNBOARD IS SUGGESTED.
- NAMING OF HORSES. (**DEADLINE DATE APRIL 3RD 2024**).
- REGISTRATION OF CHANGES OF OWNERSHIP (PARTICULARLY IF HORSE WAS SOLD AT THE SFA YEARLING SALE).
- APPOINTMENT OF TRAINER, AUTHORISED AGENT AND POWER OF ENTRY, PRIOR TO HORSE BEING ELIGIBLE TO RACE.
